

EEZYBRZY Photo & Video Business Policy

1. Deposits

- A **deposit is required** to secure your booking. Deposits range from a minimum of **\$100 up to 40% of the total price**, depending on the scope of the project.
- Deposits are **non-refundable**, unless the inability to deliver services is due to EEZYBRZY's fault.
- No booking is confirmed until the deposit has been received.

2. Cancellations & Rescheduling

- **Same-day cancellations** will **not** be eligible for rescheduling.
- Any reschedule or cancellation must be made at least **5 days before the session or event**.
- If you wish to reschedule within **5 days of your session/event**, a **\$100 rescheduling fee** will apply.
- In the case of emergencies, EEZYBRZY will work with the client on a fair resolution.

3. Deliverables & Turnaround

- Standard turnaround time is **2–3 weeks** for photo and video deliverables.
- For larger projects, extended timelines will be discussed during consultation prior to deposit.
- **Production and editing will not begin until full payment is received.**
- The **entire remaining balance must be paid immediately after the session/event has been shot and recorded**, before the editing process begins.



4. Creative Rights

- EEZYBRZY retains full **creative control** over editing style, color grading, and final presentation.
- Raw/unedited files are **not provided**, unless arranged with an additional fee.
- Client feedback is welcome, but revisions are limited to **one round of reasonable edits** per deliverable unless otherwise agreed.

5. Usage & Licensing

- Clients are granted **personal and promotional use rights** of the final edited content.
- Commercial use (ads, paid campaigns, resales) must be discussed and may require an extended license.
- EEZYBRZY retains the right to use all images and videos for portfolio, social media, and promotional purposes, unless otherwise agreed in writing.

6. On-Site Conduct

- Client is responsible for **location access, permits, and fees** (if applicable).
- Any delays caused by the client or location may reduce shooting time without affecting payment terms.
- EEZYBRZY will not photograph or film illegal activities.



7. Payments & Fees

- Accepted forms of payment: **Zelle, Cash, or Payable Invoice** only.
- Deposit must be paid immediately after consultation to secure booking.
- The **remaining balance is due immediately after the shoot/session** is completed.
- Failure to pay on time will delay the deliverables, since editing begins only after full payment is received.
- Repeated failure to adhere to payment terms may result in **termination of business indefinitely**.

8. Liability & Safety

- EEZYBRZY is not liable for unforeseen events that may disrupt services (technical failures, acts of God, accidents).
- Liability is limited to the amount paid by the client.
- Safety of staff and equipment is prioritized; sessions may be ended if safety is compromised.
