



Thank You for choosing Bombshell Brides for your on location beauty services! We are so excited to be part of your special day! Please look over the following instructions before submitting your contract!

1. Your date is reserved when you have paid the deposit of \$100.00 via debit or credit card through the online invoice sent to you.
2. **Please read through all policies and pricing carefully**, and if you have any questions, just ask!
3. The following pages should be completed by hand, scanned, and emailed back to info@bombshellbridesmobile.com. **ALL lines must be completed! Please do not leave any spaces blank.** For timing, make sure the end time is early enough to give you time for pictures, getting into your dress, and any last minute necessities like brushing your teeth! For start time, we generally back it up 2-3 hours. For up to 8 services (**SERVICES, not people**), back start time up 2 hours. For 8+ services, 3-4 hours is sufficient. We will then bring a team large enough to complete all services in that time frame. **Please contact your planner or photographer to confirm this time.**
4. To schedule your trial run, please email info@bombshellbridesmobile.com. If possible, try to schedule this on the same day as an engagement or bridal shoot so that you can see how the makeup will look in pictures!

Client Contract & Agreement

This agreement is made effective as of _____

by and between Bombshell Brides and _____.

The Bride certifies that the couple plans to be married on _____ and desires to receive hair and makeup services from Bombshell Brides. Therefore, the parties agree as follows:

***PLEASE INITIAL BESIDE EACH HEADER IN SPACE PROVIDED!**

A. SERVICES: _____

- Hair and/or makeup trial runs are available and scheduled for up to 2 hours. **Payment for trial run is due at the time service is rendered. Initial deposit cannot be credited towards trial run service.** Additional trial runs can be scheduled but will be billed at standard price.
- **Responsibility:** The above services are scheduled to be provided for the number of people given in the headcount above. The Bride will be responsible for payment for this number, even in the event that a lesser number is serviced the day of. *Additional services may be added at any time, as long as they can be accommodated by the team in regards to scheduling.*

B. PAYMENT: _____

The Bride agrees to pay an initial non-refundable retainer of \$100.00. This deposit will be applied to the final balance. An itemized invoice of all fees and services will be sent via email to the Bride 7 days prior to the wedding date, which can be paid with a credit or debit card online. **Bombshell Brides does not accept multiple payments from multiple people. If your bridal party is paying for their own services, they may pay you directly. Again, please note that ONE final payment will be taken. Invoices not paid on the due date will incur a fee of \$10 per day until paid in full.**

*All makeup includes lashes.

- Travel = \$0.75 per mile when travelling beyond Wilmington, Wrightsville Beach, Carolina Beach, & Kure Beach

- Miscellaneous Fees = Client is responsible for fees associated with event including parking garage or meter costs, ferry tickets, or any other required fees. Please anticipate these so that they can be included in the final invoice.
- Services more than 2 hours from Wilmington, NC = One hotel room must be provided for team for the night prior to services
- Services performed before 9am will result in a \$50 a hour fee.

C. DATE CHANGES _____

- In the event the Bride is forced to change the date of the wedding every effort will be made on the part of Bombshell Brides to accommodate the change by transferring all necessary services, etc to the new date. In the event that Bombshell Brides cannot provide the agreed upon services on the new date, you will be referred to a trusted company that provides similar services and is available for your new date. However, any payments made towards agreed upon services will not be refunded by Bombshell Brides.

D. CANCELLATIONS _____

- **In the event of a cancellation all paid fees are non-refundable.** If the event is cancelled 31 days prior to the scheduled date, then the total balance due will no longer apply; however the retainer will not be returned nor will any additional payments that have already been received. Once the event is cancelled, Bombshell Brides is no longer responsible to render **any** of the services mentioned in section A.
- **Cancellations must be made in writing, signed by the contracted party and sent via Certified Mail by the US Post Office. If the contacted party fails to supply written cancellation as specified before the wedding date or cancels with 30 days or less prior to the wedding date, Client shall be required to pay the full balance due.**

E. PROVIDERS AND TRIAL RUNS _____

- A trial run is required for the bride for services she will be receiving on the scheduled wedding date. If bride is not local and cannot come to Bombshell Brides for a trial, one must be completed with another licensed stylist and pictures of said trial must be sent to Bombshell Brides. This ensures that there are no surprises the day of.
- The owner, Lauren Talton, may or may not be part of your wedding team. When possible, the stylist that completes your trial run will be on the day-of team. If, for some reason, the original stylist cannot be part of that team, he team will be prepared and briefed on everything that was done at the trial run and will have photos and specific instructions to ensure the same results that were given at the trial run, if done by our team. There are no refunds for changes in team.

F. INCLEMENT WEATHER: _____

In the event of severe weather, including but not limiting a hurricane, blizzard, severe rain storm or other unforeseeable events Bombshell Brides may make the decision that it is unsafe to drive home, and hotel stay will be billed to the client. All efforts will be made on the part of Bombshell Brides to avoid such an occurrence and will only pursue this action is threat of personal life is at stake.

G. PRODUCT POLICY: _____

We use a variety of professional hair and makeup products from various brands and companies. However, obviously we cannot accommodate every individual's preferences. So if there is something you want specifically, (i.e. strictly MAC products, powder vs. liquid foundation, hypoallergenic, etc.) please let us know. If we don't have the item that you prefer, you are welcome to bring your own products and we can apply them for you. **Please ensure that individuals NOT receiving hair and makeup services will be required to provide their own products and tools. Please ensure that all guests NOT receiving services are aware of this and do not ask to borrow ANY items, including but not limited to, bobby pins, hairspray, professional tools such as curling irons, etc.**

H. PHOTO RELEASE: _____

The Bride acknowledges that Bombshell Brides has permission to obtain and use any and all photo images taken on the wedding day of bride, attendants, and guests by hired photographer and/or Bombshell Brides Team. Photos may be used for print and web advertising.

I. ALLERGY RELEASE: _____

The Bride and all those receiving services release Bombshell Brides the company, owner, and all employees from any and all liability in the event that anyone receiving hair and/or makeup services experience any sensitivity or allergic reaction to any products used. Bombshell Brides and employees will not be held responsible for sensitivities or allergic reactions to products containing ingredients not listed below as cautionary for specific attendants:
