



TERMS AND CONDITIONS

These terms and conditions relate to the photography workshops and tours organised by Robin & Timothy Moon trading as Wanderlust Imagery Pty Limited ABN 85 683 515 488, and run by Robin &/or Timothy Moon and any assistant workshop leaders.

The itinerary is subject to change to accommodate local conditions and opportunities.

PRICE

The price of a workshop is outlined on the detailed trip notes for each workshop as accessed on the <https://www.wanderlust.sydney/workshops-tours> website page. The inclusions and exclusions for each workshop are also shown on the detailed trip notes.

Overseas photo tours are quoted in Australian Dollars and correct at the time of posting. We reserve the right to change the quoted tour price should currency fluctuations or increase in service provider or accommodation charges adversely impact the price quoted.

You will be advised of any change to the tour price at least 90 days in advance of the proposed tour date.

RESERVATIONS

A deposit can be made on the Wanderlust Imagery website at www.wanderlust.sydney/workshops in the online shop, or on the Sonyscene website using the provided link or you can email Robin or Timothy Moon at images@wanderlust.sydney or call Tim on +610410682111. Each tour is limited to a maximum number of participants. Trip spaces will be confirmed in order of receipt and upon payment of deposit.

PAYMENT

To confirm your place, payment of the deposit is required at time of booking and may be made through our Paypal account, pay on the Sonyscene website, or you can contact Robin for other arrangements (images@wanderlust.sydney). Once your reservation has been confirmed, payment of the trip fee balance is required 6 weeks prior to the commencement of the workshop. Please note fees may apply when remitting the trip fee balance by PayPal. We reserve the right to cancel your booking if payment is not received when due, where the Cancellations and Refunds clauses, listed below, shall come into effect.

CANCELLATIONS & REFUNDS

Should you wish to cancel your booking, you must advise us in writing (email is fine). We try to have a fair refund policy that works for both you and us:

If you don't request a refund of your deposit 90 days out or longer, we will assume you wish to come, and the balance is payable.

Deposits are generally refundable, up to 90 days prior to the event, subject to the following :

- If you are cancelling more than 90 days from the workshop date, we will refund you in full if the workshop is not full and, after your cancellation, we still have the minimum number of bookings to run the workshop.
- If the workshop is full, and we have turned away other customers, and you are cancelling within 90 days of the workshop date, we won't refund you unless your place is filled by someone else.
- If after you cancel your booking the workshop numbers fall below the minimum number required to run, and you are cancelling within 90 days, we won't refund you.

No part refunds are made for unused portions or services of a workshop.

HEALTH REQUIREMENTS

The tour is designed to be suitable for people of all ages in good health and moderate fitness. While activities are not strenuous, on some trips we will be hiking on tracks in wilderness areas. It will be necessary to carry your own camera equipment, extra clothing, food and water for these activities. Should you have any concerns about your own capabilities and/or fitness in relation to a particular trip, please contact us to discuss this before sending your reservation form. You are required to disclose any medical or physical condition that you have which could create a risk for you or any other participants. We assume no responsibility for medical care nor guarantee to meet any special dietary requirements.

INSURANCE

Personal and Travel insurance is recommended for all participants and their equipment and personal belongings as no insurance is included in the trip fees. Please be aware of any current COVID issues and that travel arrangements and your ability to participate in the workshop maybe affected.

RESPONSIBILITY

The responsibility of Wanderlust Imagery is strictly limited.

As a workshop operator, Wanderlust Imagery may organise, promote, and sell programs consisting of services that it purchases from various suppliers.
